

51ST SECRETARY ANNUAL REPORT FOR THE TERM 2024-2025

Dear Members,

It gives me immense pride and heartfelt gratitude to welcome you all to the 51st Annual General Body Meeting of the Shantinagar Sindhi Association for the year 2024–25.

I extend a very warm welcome to all the **new members** who have joined our Association during the year and are now part of our growing family.

It is both my **privilege and honor** to present before this august gathering the **Annual Report** of the Association's activities, highlighting our key events, achievements, and the **audited statement of accounts** for the financial year ending **31st March 2025**, for your kind adoption.

Under the dynamic leadership of our **President, Sri. Kishan Kishore S. Bathija**, the year has been both **eventful and fulfilling**, marked by purposeful initiatives that upheld our cherished values of **Service and Brotherhood**. Each event reflected our collective commitment to community bonding, preservation of culture, and support for those in need.

Our team assumed office on **5th January 2025**, when I had the honor of being elected as the **Hon. Secretary**. It has been a matter of great satisfaction and learning to serve the Association in this capacity. During the year, we convened **seven Managing Committee meetings** to ensure smooth coordination of our initiatives.

The Association also **co-opted two members** to the Managing Committee:

To ensure effective planning and execution, various **subcommittees** were constituted, each focusing on a specific domain. The highlights of their work are presented below.

1. Philosophical and Cultural Subcommittee

Chairman: Sri. Sanjay B. Talreja

• Vaikuntha Ekadasi (10th January 2025):

For the first time, the Association organized the sacred Vaikuntha Ekadasi Pooja Vaikuntha Dwar was created and all devotees took a blessings of lord going through the Dwar at Leela Maa's Satsang Hall. All day long devotees participated in the spiritual gathering and experienced divine serenity. Ladoo prasadam and snacks were distributed to all attendees

• Lal Lohi Celebration (13th January 2025):

The festival of Lal Lohi was celebrated with great fervor at *Mudtank, Langford Town*, attended by over **1,800 guests**, including children. *Jog Maya Pooja* was performed by *Maharaj Sri. Sanjeev Setpal Ji*, with *Mrs. and Mr. Kishan Kishore S. Bathija* leading the rituals. Firewood was provided for members at the venue, and a *South Indian dinner* with *chaats, fruits*, tea, coffee and badam milk was served as prasadam. The event was graced by *Ex-MLA of BJP Sri. Shivkumar*, who highly appreciated the Association's efforts toward fostering community spirit.



A landmark occasion — for the very first time, the Association organized *Chaliyo Sahib*, the 40th Day celebration of our Isht Dev **Jhulelal Sai**, as a cultural and devotional trip to **Srirangapatna**. Six buses were arranged, and nearly 300 devotees joined together to offer prayers. A total of **52 Behranas** were respectfully and devotionally immersed on the banks of the *Cauvery River*.

The pooja was performed by **Maharaj Pradeep Inderpal Sharma**. Breakfast, lunch, high tea, and prasadam were served to all, and small *pakhars* were distributed as a token of blessings.

The devotees were deeply touched by the spiritual experience, and the event received overwhelming appreciation, with many requesting that it be made an **annual tradition**.

Special appreciation to *Chairman Sri. Sanjay B. Talreja* for executing these events flawlessly, and to *Sri. Harish Kumar Khaturia* for his valuable support in organizing the devotees.

2. Sahayata Subcommittee

The Sahayata team organized several welfare programs to support the less fortunate:

- On **25th May 2025**, assistance was extended at two centres *Bharatiya Grameen Mahila Orphanage* (HAL, Bengaluru) and Gandhi Old Age Home.
- For 180 inmates of the orphanage, breakfast, bathing soaps, shampoo, hair oil, toothpaste, brushes, washing powder, notebooks (200 pages), and A4 printer papers were distributed. A sum of ₹7,500 was donated for their welfare.
- At Gandhi Old Age Home, breakfast was provided to 120 senior citizens and 10 staff members. Phenyl, brooms, washing soaps, fruits, and adult diapers were also distributed, along with a donation of ₹5,000.
- On **22nd June 2025**, lunch was served to 80 children at *Need Base India, Shantinagar*, along with towels, notebooks, fruits, mixtures, and sweets.
- On 12th October 2025 (Deepavali Distribution): 17 essential items including ghee, dates, tea, vermicelli, cookies, honey, sweets, toiletries, and books were distributed to 150 needy Sindhi families.

These programs were made possible by the generosity of our donors and volunteers. **Special thanks** to *Smt. Sharada Talreja and her team* for serving a delicious breakfast to the Office Bearers, Managing Committee Members, and the 150 beneficiary families.

3. Fellowship Subcommittee

- 21st September 2025 (Mahalaya Amavasya): 21 members visited *Mysore Pingarapole Society* housing 4,900 cattle. 1 truck each of wet and dry grass, 10,000 chapatis, 100 kg of jaggery, and 5 bags of cucumbers and carrots were offered as feed. *Gau Pooja* was performed by *Maharaj Sri. 
During the year, we recorded **10 demises** and **19 suspensions**. The total membership strength now stands at **357 members.**


























6. Education and Scholarship Subcommittee






