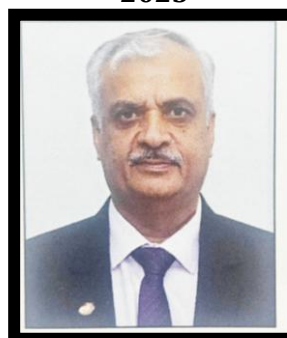

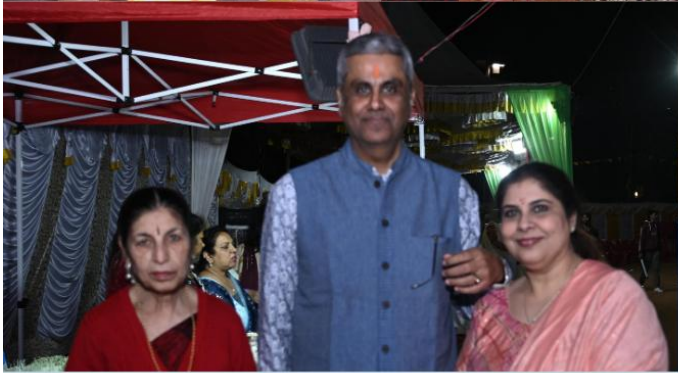

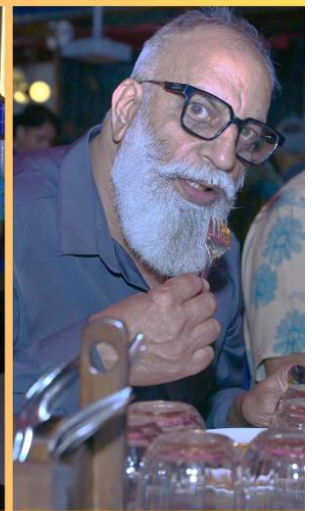

AUDITOR'S REPORT

To
The Members,

I have audited the Balance sheet of "SHANTINAGAR SINDHI ASSOCIATION", Bangalore as at 31st March 2026 and the Income and Expenditure Account for the year ended on that date annexed hereto. These financial statements are the responsibility of the office bearers and Managing Committee of the Shantinagar Sindhi Association. My responsibility is to express an opinion on these financial statements based on our audit.

I conducted my audit in accordance with auditing standards generally accepted in India. Those Standards require that I plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. 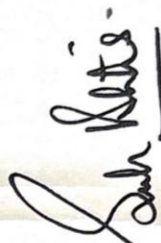
